Status of contributions of BWC, CCW, CCM, OTW as at 28 February 2017

Introduction

1. The present document is a summary of the financial contributions of the four disarmament Conventions. Its purpose is to illustrate the impact that unpaid receivables have on the cash available to conduct current conferences.
2. The Summary table below shows the cash available to the Conventions as a result of Member State contributions and the total unpaid contributions.
3. Annex I presents a breakdown of the outstanding receivables by Member State and by Convention.
4. Annexes II to V present a breakdown of the outstanding receivables by Convention, by Member State and by year of conference.

1. **Net cash balance for 2000-2016 conferences** represents the invoices that have been issued to Member States for previous years conferences but have not been paid.
2. **2017 Assessed contributions still due from Member States** represents the total of unpaid assessed contribution invoices, adjusted by any credits brought forward from closed conferences, less overpayments from member states. Total net contributions receivable as at 28 February 2017 were as follows: BWC \$26,937.27, CCW \$881,965.35 and OTW \$195,466.05. For CCM, the UN has received more payments than it has invoiced because overpayments of \$85,955.74 from some Member States more than offset unpaid contributions of \$47,746.31 from other Member States.
3. **Net cash received by Conventions** represents the cash available to the United Nations to hold current meetings. For 2017 conferences, the estimated meeting costs are equivalent to the **Assessed contributions billed to Member States**, totalling \$3,183,500.00. Unpaid receivables reduce this cash to \$1,340,269.35. All conventions have a resulting deficit in the cash required to cover the remaining costs for 2017.
4. **It is critical to note that if all contributions are not received by the time the UN has to make payments for conference costs, the UN will be unable to host those conferences.**
